



## Third Eye FZ LLC Privacy Policy

THIRD EYE FZ LLC and its affiliates ("Third Eye" or "we") are committed to protecting the privacy of the personally-identifiable information that we collect from you as you use this Web site (the "Site"). The scope of Third Eye's commitment is detailed in this Privacy Policy. By submitting information, you agree to Third Eye's use of such information as described herein.

Third Eye collects personally-identifiable information on certain areas of the Site when users register, request publications or other information, sign up for workshops and events, apply for jobs, and participate in user posting areas, such as surveys. The personally-identifiable information collected may consist of information that you provide, such as names, mailing addresses, e-mail addresses, telephone and fax numbers, and, for recruiting purposes, any other personally-identifiable information on your resume. Third Eye does not collect any other information that you do not visibly enter, such as your IP address, browsing pattern on the Site, click stream, etc.

Third Eye uses your personally-identifiable information to fulfill your requests for information, to process your requests to participate in workshops and events, to evaluate any job applications or other employment-related inquiries that you may submit, or for such other business purposes as you may initiate or request. We may keep any of your personally-identifiable information on file and use it to contact you for recruiting purposes. Third Eye also uses personally-identifiable information to perform statistical analyses of user behavior in order to measure interest in specific areas and information posted on our Site. Third Eye may provide your personally-identifiable information to any of its affiliates worldwide for such purposes.

Third Eye shall not intentionally disclose or transfer (and shall take reasonable steps to protect the confidentiality and security, and to prevent the unauthorized or accidental disclosure of) your personally-identifiable information to third parties (i.e., persons or entities that are not affiliates of Third Eye), whether for such third parties' marketing purposes or otherwise, subject only to the following four exceptions: Third Eye may disclose your personally-identifiable information to third parties in the event that such disclosure is required by the laws, rules, or regulations of any nation, state, or other applicable jurisdiction; Third Eye may disclose your contact information to third parties as appropriate for Third Eye to make transmissions or deliveries to you; Third Eye may disclose your personally-identifiable information if, in connection with submitting the information, you consent to such disclosure; and Third Eye may disclose contact information for you in response to inquiries by bona-fide rights owners in connection with allegations of infringement of copyright or other proprietary rights arising from information you have posted on the Site or otherwise provided to Third Eye.

By using the Site, you consent to the collection, use, and storage of your information by us in the manner described in this Privacy Policy.
